

Power of Attorney

I (hereinafter referred to as “ABC”) hereby appoint the person described below as my agent (hereinafter referred to as “XYZ”) and entrust him/her with the filing of any and all subscription requests described below with regard to (1) a mobile phone service contract, etc., (2) a fixed-line service contract, (3) an electric power service contract, and (4) a gas-related contract of SoftBank Corp. and agree that ABC’s information will be disclosed to XYZ to the extent necessary for the entrusted procedures. This Power of Attorney will remain effective for a period of three months from the date of preparation.

\*The subscriber him/herself is required to fill out the form (including the agent’s (XYZ’s) section) by hand without fail.

- The agent must be either the subscriber’s family member, guardian, curator, assistant, facility staff or assignee in the case of assignment. \*However, this does not apply to any repairs of mobile phones.
- You need to submit the agent’s personal identification documents as well as documents certifying the relationship with the subscriber, such as family identification documents. \*The subscriber’s identification documents (photocopies accepted) are also required in the case of new subscription, change of service provider, assignment or succession.
- In the case of a new subscription contract, only if the subscriber is disabled and is unable to come to a shop on his/her own, the Company will accept a subscription request through the agent.
- If the assignor cannot come to the shop in the case of an assignment contract, the assignee can perform assignment contract procedures after obtaining a power of attorney from the assignor.
- Agents cannot submit a request in some cases such as changes in a telephone charge statement, and changes in password.
- The term “installment contract” means an individual installment purchase contract under the general conditions for individual installment purchases or an individual credit purchase intermediation contract under the general conditions for intermediation of individual credit purchases.
- If this documents has any omissions, errors, etc., we will confirm with the subscriber through telephone.
